2 NIFs for GN4 Phase 1

NORDUnet and the Nordic NRENs have identified the following categories in which our 28 NIFs fit:

- General: 1 NIF
- SA1: 2 NIFs
- SA2: 2 NIFs
- SA3: 2 NIFs
- SA4: 3 NIFs
- SA5: 3 NIFs
- SA7: 4 NIFs
- Security: 4 NIFs
- JRA1: 4 NIFs
- JRA3: 3 NIFs

One NIF, titled “European Low Latency High Quality Collaboration (LLHQ)”, we propose for JRA1. However, this one could fit into SA1 also. We ask you to consider this as well, and we value your opinion where it might fit best.

We realize that the 4 NIFs on security belong in different activities in the GNx structure. However, we find that stepping up on security activities in the project is currently essential, and so wanted to highlight those.

We have one NIF that is marked as “general”, as we feel the topic of account management is important but outside the scope of any particular activity. Note that this NIF can be seen as complimentary to NIFs on product management and operations assurance prepared by Toby Young and Mark Johnston, respectively.
