It is also a fair assumption that a lot of innovation in terms of services takes place in the NRENs outside of current GÉANT activities.

Different activities contribute to draw the landscape of existing activities and services:

- the TERENA compendium: a high level synthesis which gives key figures
- "Campus best practices": more qualitative case studies which can serve as an inspiration
- The Nordic NREN collaboration with the same aim: service matrix.
- Task Force Management of Service Portfolios (TF MSP in TERENA).

These activites have produced great results, they can be used along with other surveys to help have a precise overview of existing services and in the future to identify the best practices. However, it is challenging to know if services can be "exported" to other contexts: are NRENs willing to share what they have built to the larger commuties? Are there legal or other obstacles?

This project aims to address these challenges.
